1. Introduction

The Office of the Controller of Examinations shall be responsible for assessing continuous learning process of the students by maintaining best quality and standard in examination process and ensuring confidentiality. It is the duty of the office of the Controller of Examinations to arrange, prepare, schedule, conduct, publish and maintain records of CIE and Semester End Examinations of the students of all UG, PG and Ph.D. programmes.

The responsibilities of the office are:

- Collection of student bio data from the students.
- Mapping Electives from the students for the current semester.
- Conducting CIE test for the students of various UG/PG Programmes.
- Preparation of exam schedule, Hall allocation and Seating arrangements for Continuous Internal Evaluation Test (CIE).
- Collection of Question Papers from the departments, printing and disseminating for CIE test.
- Collecting Practical examination schedule from the departments.
- Appointment of External Examiners for practical examinations.
- Ensuring students attendance percentage during semester.
- Lack of attendance, debarred and withdrawal Panel of Examiners preparation from various Institution/Universities.
- Exam schedule preparation for Semester End Examinations.
- Appointment of Hall Invigilators, Hall Chart, Seating arrangements, Squad and Chief Superintendent etc.
- Appointment of Evaluators, Chief Examiners and Chairman for Valuation.
- Result Processing, Grade Sheet Printing and conducting Graduation conduction

2. Academic Calendar and Scheduled Events

Office of the Controller of Examinations is scheduled to follow the academic activities declared by the Academic Council. Office of COE is mainly responsible for scheduling and conducting Continuous Internal Evaluation Test (CIE) and Semester End Examinations (SEE) comprises of Practical, Theory and Project work of the semester and publishing the results within the stipulated time for all UG and PG programmes. Dates of various academic events planned in the academic calendar which is to be executed for every semester of the academic year charted by Academic Council and Dean Academics (approved by the principal) and to be regulated by the office of the Controller of examinations.

2.1. Continuous Internal Evaluation Test

CIE tests are informed to the students through circulars and Notice Boards to the students earlier to make them aware of the examinations. Syllabus of the CIE tests will be 1 ½ units (CIE test 1 and 2) and 2 units for (CIE 3).

2.2. Question Papers Collection and scrutiny

Two set of Question Papers are being collected for Continuous Internal Evaluation test for all UG and PG programmes. The question papers are forwarded to the Head of the Departments to scrutinize and forward the same to the office of the Controller of Examinations. COE will be deciding the examination question papers based on the grade awarded to the course respectively. The other set of question paper will be used for Retest/Improvement tests for the students.

After examination, within the 10 days a review of the concluded CIE test will be reviewed in the Name of CIE Test performance review meeting conducted by the department head by Controller of Examinations / Dean Academics to further actions.

2.3 Conduction of CIE Test

A schedule for invigilation duty is prepared and informed to the concerned faculty by the Exam Cell. After the examination, answer scripts are collected by the invigilators and handed over to the Exam Cell along with attendance report. Exam Cell hands over the answer sheets to the faculty handling the subjects through concerned Examination co-ordinators of the departments within a day.

Question Paper Scrutiny Committee

QP for Semester End Examinations will be collected from the External/ Internal examiners in the ratio of 2:1 per course. After collection of QPs completely, the office of the COE will be arranging a meeting. This meeting will be chaired by the Principal, HODs along with Associate Professors of various departments to scrutinise the QP. Members of QP committee will check the QPs with syllabus, pattern, weightage of marks, data, diagrams, tables, charts and levels of Bloom’s Taxonomy and approve the question paper. Examination question paper will be decided by the Controller of Examinations based on the Grades given.

Pre-valuation Board Committee

This committee is formed to analyse the complexity of question papers for instance, out of syllabus questions, data missing, lengthy/time consuming, typo errors, etc. This includes feedback of the students and the course handling faculty. Moderation shall be raised by the HoD with appropriate reasons and supporting documents from the teaching faculty is forwarded to the principal. Based on the discussion, with the principal and Dean-Academics moderation of marks will be considered for a course claimed by the HoDs of the department concerned approved by the Principal.

This is forwarded to the Chairman of the board during valuation and marks shall be awarded to the students based on the minutes of the pre-valuation board meeting.

Malpractice Committee

This committee is formed to enquire students who indulge in malpractices indulged during the Semester End Examinations (Theory/Practical). The hall superintendent collects the answer paper / supporting materials along with written statement from the candidate concerned and sends it to the COE/Chief Superintendent. The Chief Superintendent forwards the same to the COE along with a covering letter, students' seating location chart and hall superintendent's report.

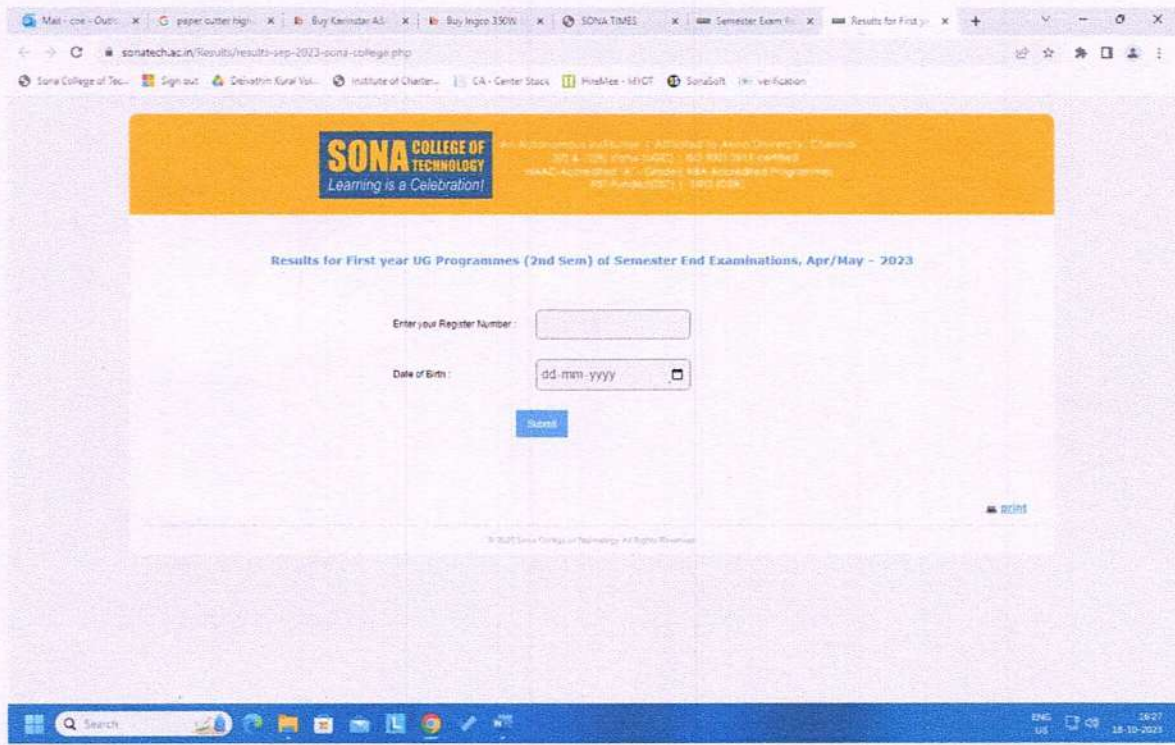

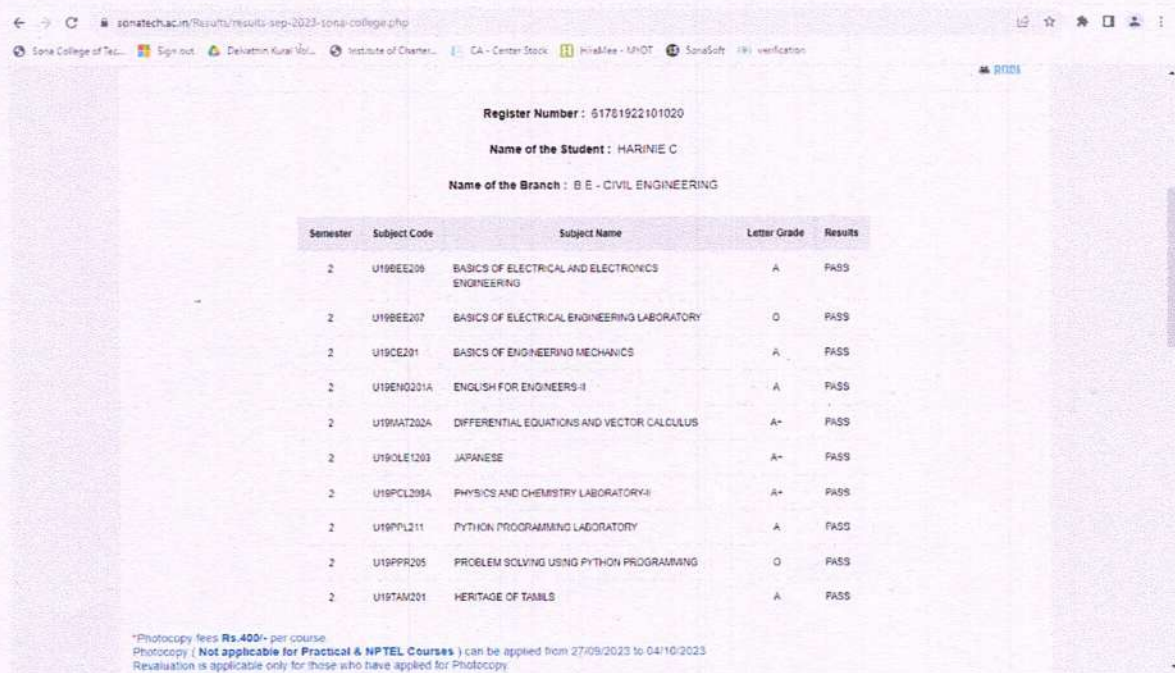

The below screenshot represents webpage for publication of results to the students.



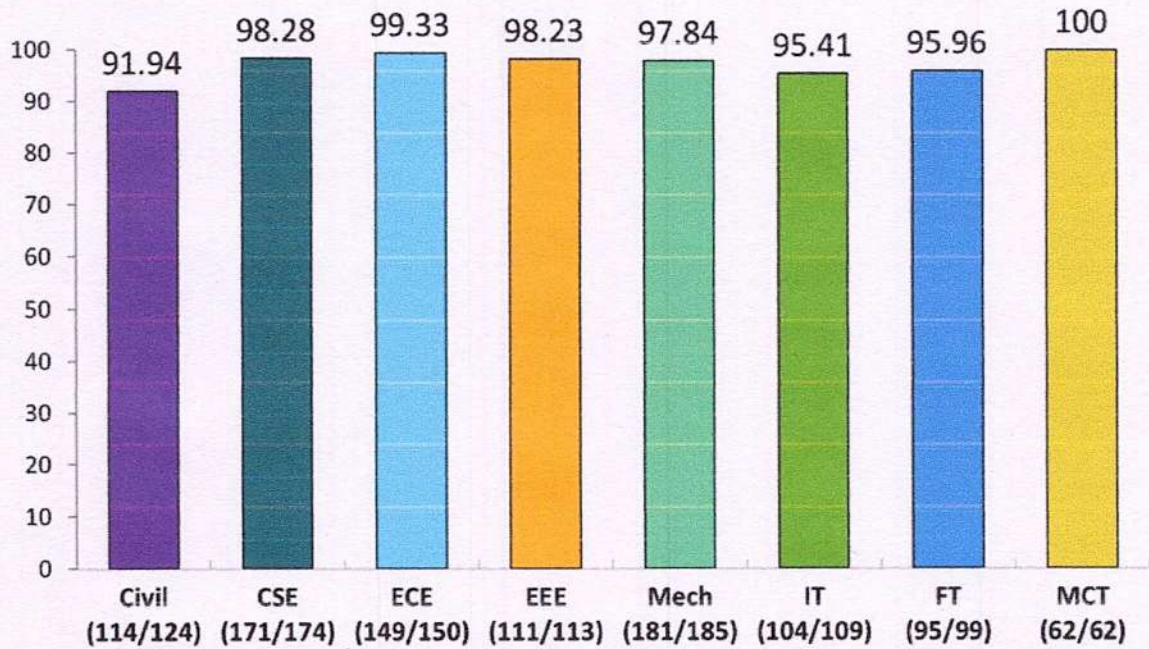
The below screenshot shows the results display page in website to the students.



Pass percentage (at the time of declaration of results)

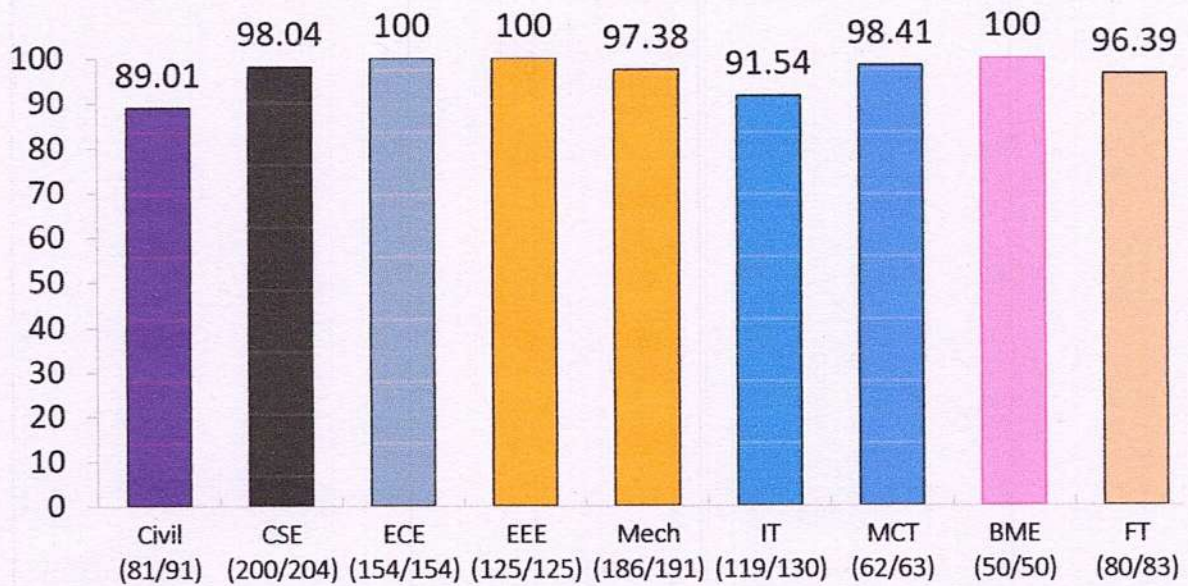
B.E/B.Tech Semester 7

Overall Pass Percentage = $987/1016 = 97.15\%$



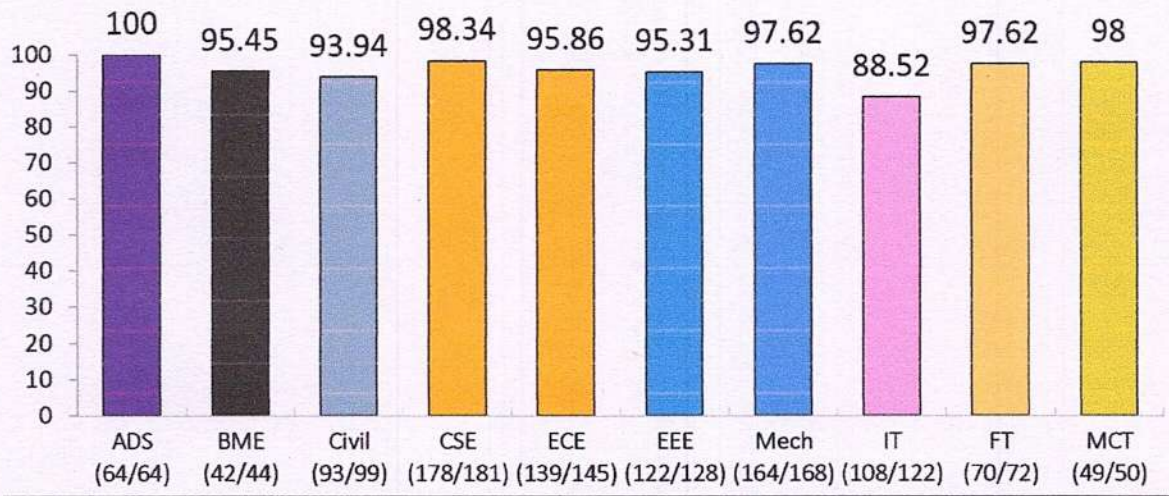
B.E/B.Tech Semester 5

Overall Pass Percentage = $1057/1091 = 96.88\%$



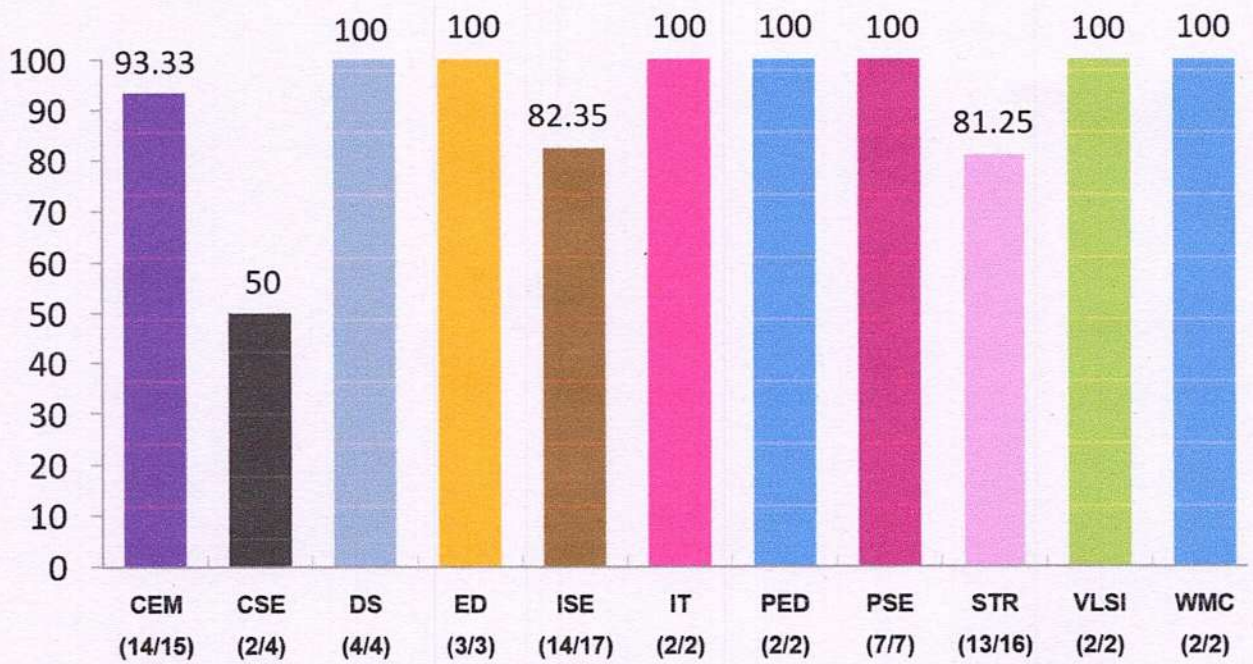
B.E/B.Tech Semester 3

3. REVALUATION

All the candidates irrespective of the GRADE/MARK secured in the Semester End Examinations can apply for Revaluation. Photocopy or Revaluation of the answer scripts are given only for theory courses. Practical / Online courses / optional language courses are not eligible for

reevaluation. A Candidate who would like to apply reevaluation for a course, he/she need to obtain his/her photocopy of the answer script (of the course concerned) first before the deadline mentioned. If any discrepancy is being noticed in the Photocopy of the answer script, the same may be brought to the notice of the Controller of Examination.

- After receiving the photocopy, the candidate can check discrepancies in awarded marks, total mistake and marks omitted etc., by his/her own or he/she can also discuss the same with course experts. If the expert(s) is/are convinced that the candidate deserve to get more marks than the awarded marks, then he/she can recommend the student to apply reevaluation.
- Once the student gets approval from the expert, they need to get reevaluation application and submit the same after getting signature from course expert, HOD and the Principal along with the photocopy of the answer script to the Office of COE. If a candidate is not satisfied by his/her reevaluation results, they can apply for Review/Challenge.

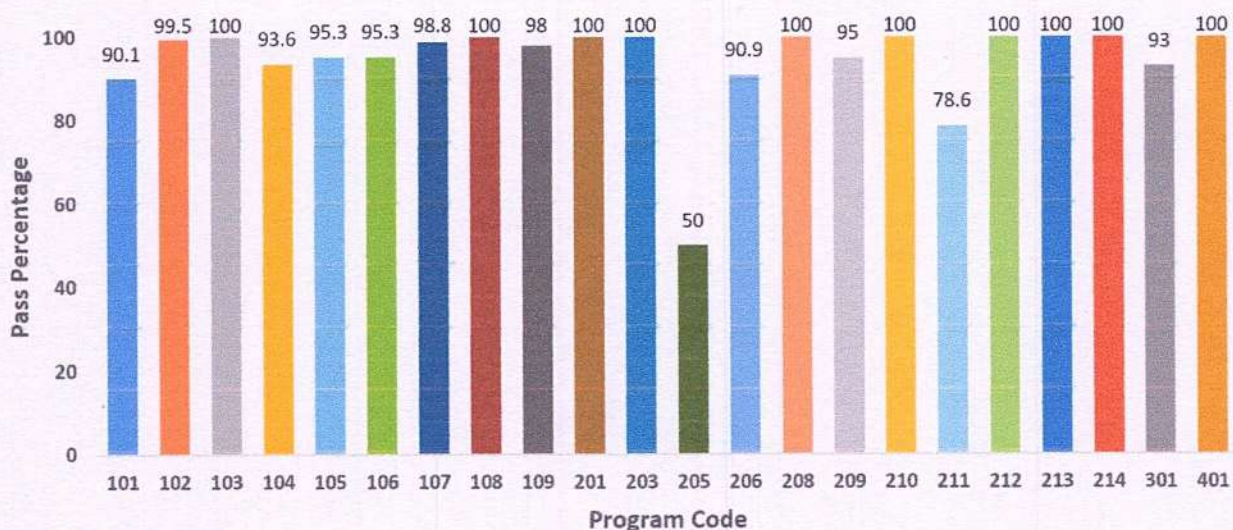
