The 15th online BOS meeting started at 10.00 am through Microsoft Teams.

Dr. M. Rameshkumar, Associate Professor welcomed all the BoS members. Faculty Members and Students of Fashion Technology Department for the 15th BoS Meeting. 2021.

Chairman, Dr. D. Raja introduced the BoS members and briefed about the department achievements happened in the last six months.

The BoS members recommended the following points during the discussion which are detailed below:

DISCUSSION ON SYLLABI OF THE COURSES IN THE SEMESTER 7

The syllabus of 7th semester courses was reviewed by the BoS members and it is as follows:

PROFESSIONAL ETHICS AND HUMAN VALUES

Dr. C.V Koushik conveys that this course can be handled by the department faculty so
that it is possible to give FT related examples and issues. Members approved the syllabus.

RETAIL MANAGEMENT

- Dr. Kandhavadivu suggested adding Retail Analytics and inventory turnover.
- Mr. C. Rajesh Kumar said these topics can be added to the 3rd and 5th unit.
 Dr. Kandhavadivu conveyed that course on Visual Merchandising is existing in this curriculum and appreciated that left out topics are accommodated here.
- Mr. Devadas asked do they have any finance side of the product and pricing.
 Mr. C.Rajesh Kumar said these topics are there in the 3rd unit of this syllabus and
 Mr. Devadas acknowledged the same.

FASHHON PORTFOLIO AND PRODUCT DEVELOPMENT LABORATORY:

- Ms. Vidya Vivek suggested to add selection of line (market) segment, budget analysis, trend and forecasting segment analysis for a specific line. Dr.Palanirajan suggested to include a target group and analysis of customer. He also suggested to give freedom on number of experiments and to mention minimum garment to be constructed.
- · Ms. Vidya vivek also accepted his point.

ACCESSORY DESIGN AND EMBELLISHMENT LABORATORY

 Ms. Vidya vivek enquired whether this course covers garment or fashion accessories and would be taught based on industrial approach and mass production. Dr. Vidya clarified that this course deals with both garment and fashion accessories and would be taught

- based on the industry practice. The topics on fashion accessories and embroidery would be useful to the students willing to start their own Boutique.
- Dr. Kandhavadivu agreed Dr. Vidya's justification and added that this will be the course which students will be showing great interest. Also she advised to include an experiment on machine embroidery and its design creation process.
- Ms. Vidya vivek suggested to include the attaching procedure of button, buttonholes, eyelets using industry grade machinery and hand press machinery.
- Dr.Palanirajan stated that offering this course in the 7th semester is very basic and need to refine the syllabus.

The syllabus content is refined.

DRAPING TECHNIQUE LABORATORY:

- Dr.Palanirajan advised that the pattern has to be prepared from draping techniques.
 Dr.Priyalatha confirmed that each and every exercise will be ended as a pattern.
- Ms. Vidva vivek suggested adding pattern matching and hooking.
- Mr.Somusundram suggested that anthropometric concept should be taught for effective draping and to include an experiment on draping with intimate apparel.
- Ms. Vidva vivek replied that intimate apparel can be taken as the last part of fashion learning. Also madam recommended to do research on suitable fabrics for draping by collecting swatches.
- Dr. Kandhavadivu suggested to add topics on cowl, cascade, twisting and peplums effect
 under advance draping experiment. Also madam asked to include busher and bias skirt
 dress and braziers.

INTERNSHIP

- Dr. Raja explained about the pattern of the internship to the board members and Dr.Palanirajan suggested to include evaluation done by the industry mentor as a component of internal marks.
- It is also decided to offer internship in the seventh semester as a mini project to the 2018-2022 batch students. This is approved as one time measure due to corona lockdown.

INNOVATION PRACTICES (MINI PROJECT)

- Dr. Kandhavadivu enquired about the type of projects carried out by the students in the innovation practices. Dr. Priyalatha explained about the type of projects carried out by students in their third semester.
- Dr. Raja explained that the procedure of reviewing the progress of the mini project three times in the semester at periodic interval before final viva by an appointed committee of internal faculty. The final viva voce will be conducted by the appointed committee of an external and an internal faculty.
- Dr.Palanirajan suggested that innovation is a generic word and to be addressed with its clear needs. Dr. Akilandeshwari, Academic Dean suggested to rephrase the title as "Mini-Project" and to ensure that all the practical courses should contain only 3 course outcomes.
- It is also recommended to rename innovation practices offered in the 4th semester as Mini Project – 1.
- Mr. Devadas suggested to consider mini project works on reducing non-productive work.
 inter-departmental collaborative works, real time problem solving, sourcing of raw material and sample development.

DISCUSSION ON PROFESSIONAL ELECTIVES FASHION PHOTOGRAPHY

- Ms. Vidya vivek asked to include topics on fashion element such as background, choosing the model, location planning, properties used, colour theory themes concept behind the photography. Also she asked to include study of fashion looks and more input on fashion related components in the syllabus content.
- Mr. Devadas recommended to include this as a lab component.

LEAN MANUFACTURE IN APPAREL INDUSTRY

Mr. Devadas enquired about offering practical course on lean application, because of lack
of industry setup inside the institute. Dr. Raja clarifies that students undergoes 2 weeks inplant training every semester and they get opportunity to learn about lean. Also this can
be implemented through internship.

Mr. Pradeep varman suggested adding Concept of 7s. (Safety and Sprit).

GLOBAL TRADE AND EXPORT DOCUMENTATION

- Mr.Somasundaram suggested swapping unit 3 and unit 4.
- Dr.Palanirajan asked to add more content on unit 5 documentation. For that Mr. Somasundaram justified that all the content on documentation had been added already in unit 5.
- Mr.Somasundaram suggested to include reference books on Trade Policy, Government of India.

LUXURY BRAND MANAGEMENT

No comments.

LEATHER TECHNOLOGY

- Dr. Kandhavadivu asked to include topics on structure of leather, Structure of skin, process of collecting skin, pre-tanning process, and tanning process, de-tanning (Unit 1), different type of leather (Unit 2), different types of machines, tools, and equipment involved, special leather sewing machines, needles (Unit 3), method of pattern making, cutting, sewing, and fasteners for leather (Unit 4).
- Dr.Palanirajan suggested to include majorly on leather garments and minimum on leather accessories.

FASHION STYLING

 Ms. Vidya vivek suggested adding studies on body challenges in Unit 1, celebrity styling, types of shows, and collaboration with other brands. Also to include choice of model for video or photography in commercial style, theater styling and brand photography.

ENTREPRENEURSHIP DEVELOPMENT AND MANAGEMENT OF APPAREL UNITS

 Ms. Vidya vivek suggested to include topics on women entrepreneur. SWOT analysis and financial assistant report.

INDUSTRIAL SAFETY AND HUMAN RESOURCE MANAGEMENT

Dr. Palanirajan suggested to add case studies related to apparel.

DISCUSSION ON SYLLABI OF THE COURSES IN THE SEMESTER 8 PROJECT WORK

- Dr. Raja explained about the pattern of the project work which is offered with minimum
 three internal reviews and a model review to monitor the progress of project work by
 appointed committee of internal faculty. The final end semester viva-voce examination
 will be conducted by an internal and an external examiner. It is also informed about the
 decision made by the management to the members that each project work should be
 ended by successfully publishing in international conference or journals.
- Dr. Raja enquired about the practice followed in VIT and PSG College. Dr.Palanirajan
 informed in the meeting that in VIT includes evaluation of industry experts in their final
 evaluation. Dr. Kandhavadivu explained that in PSG College, project work happens in
 two phases as Phase 1 and phase 2.

DISCUSSION ON SYLLABI OF THE COURSES IN THE EARLIER SEMESTERS PRINCIPLES OF MANAGEMENT

- Dr. S. Priyalatha explained to the members that POM was moved to professional elective list in the last 14th BOS meeting and now it is planned to offer as NPTEL course.
- Dr. Kandhavadivu conveyed that POM generally comes under basic science category and asked to offer under open elective, if it possible. It is explained to the members that due to lack of textile fashion related courses in the NPTEL list, it is planned to offer POM in the coming 5th semester to 2019 batch.

- Dr. Akiładeshwari informed members that according to the Regulation 2019, transfer of
 credit is only possible with profession elective courses and not for open elective.
- Dr. Priyalatha informed that only POM is planned for credit transfer now.
- Mr. Devadas asked about the similarity of POM syllabus content with the NPTEL offered.
- Dr. Kandhavadivu conveyed the process of credit transfer as follows: first need to put in
 the approval of committee, once it is approved later they may go for approval transfer. It
 is informed that the mapping of NPTEL course with FT, SCT syllabus will be submitted
 for credit transfer approval.

FASHION BRAND MANAGEMENT

- Dr. Privalatha explained to the board members that Professional Elective on Fashion Brand Management is introduced since the Draping Technique is moved from elective to practical list.

DISCUSSION ON NPTEL. ONE CREDIT AND VIRTUAL INPLANT TRAINING COURSES OFFERED TO STUDENTS IN THE LAST SEMESTER.

NPTEL COURSE

Mr. Gopinath informed members that course on Six Sigma and Entrepreneurship Skills offered by NPTEL was taken by current 6th semester students of 2018 batch. Students attended all lectures and attended all assignments and found it useful and interesting. The online exam for this course was postponed by NPTEL due to this pandemic.

ONE CREDIT COURSE

 Ms. Kanimozhi informed members about the One Credit Course was offered to current 2nd and 3rd year students on Procedure to Setup a Boutique. Resource person was Nithya kumari, designer and founder of NITURI Studio, Chennai and Salem, 110 students attended this course and got benefitted.

VIRTUAL INPLANT TRAINING COURSE

- Two day Virtual In-plant training session was arranged to current 2nd year students to fill the gap in offering in-plant training to the students in this pandemic situation. Industrial experts were identified to explain the students about the actual industrials Practices on the topics on weaving, knitting, chemical processing, overview of apparel industry, production and quality practices in apparel industry. All the 84 students attended this training and submitted the reports on all the six sessions. At the end they attended viva voce.
- Dr. Akilandeswari conveyed that all theory courses should have 5 COs and practical course should have 3 COs with at least 3 COs at HOTs level

Dr. A. Jebatin rajwin proposed the vote of thanks to all the BoS members.
