The IQAC Coordinator discussed the following points during the meeting:

- The agenda, Minutes of Meetings & faculty attendance at the department Committee meeting are essential.
- The syllabus was framed and approved by the department Committee for VAC, along with its outcomes.
- The graduation percentage of the students is to publish on the website.
- The platform's management system handbook have used for examination methods, including user interface screenshots. Examine cell guidelines for IT-integrated CO assessment.
- The faculty must prepare a complete COs and Pos plan, and related learning strategies with the evaluation procedures should be developed.
- The compositions of collaboration/related documents indicating the nature of collaboration and activities year-wise
- The HEI portal should provide the collaboration summary indicating the starting date, wind-up date, nature of cooperation, etc.
- The minutes of the meeting report of the student redressal committee meetings, prevention of sexual harassment committee, and Anti Ragging committee is essential.
- Proof has to maintain for the constitution of the Internal Complaints Committee,
   Grievances Redressal Committee formation, and Anti-Ragging Committee as per UGC regulations.
- The Alumni Association with UK chapters has dramatically impacted the institution's growth and provided invaluable support services. Its comprehensive description has helped foster a closer bond between alums and the university, promoting further initiatives to benefit both parties.
- A proper template must list the Quality initiatives and programs organized through the IQAC cell.
- The Academic Audit schedule with reports and ISO internal & external audit schedule must be included, along with their respective descriptions.
