

Instructions for applying Condonation

- 1) A candidate who could secure attendance percentage between **65% to 74.9 %** (Regulation 2019) and **70% to 79 %** (Regulation 2023) in the pursuing semester (current semester) due to
 - (i) **Medical Grounds**
 - (ii) **Participation in various Academic activities**
 - a. Paper or Project Presentation in National/International conference with prior approval from HOD and The Principal
 - b. NCC/NSS/Indian Army Programmes in State/National Level with prior approval from the HOD and the Principal and issuing certificates after participation.
 - (iii) **Participation in various Sports activities**
College /University/State/National/International level sports events
- 2) The above mentioned eligible students can apply, for Condonation by paying prescribed fee of **Rs.4000/-** per student per semester (for First Time request) and **Rs.6000/-** (for second time request) and submit their Condonation form after getting duly signed by the concerned authorities. Payment can be paid by **CASH** to accounts department or **DD** in favour of “**Sona College of Technology**”
- 3) Student may fill up the details with the help of CC’s and forwarded after complete authentication from HOD and the Principal. (**atleast a week before the commencement of SEE to the office of COE, except medical grounds**)
- 4) A student **can be allowed only TWICE** under condonation for his/her entire period of study.
- 5) In case a student is below the condonable limit **65% to 74.9 %** (Regulation 2019) and **70% to 79 %** (Regulation 2023), then he/she is not eligible to take up the current semester courses in Semester End Examinations. Such students needed to redo the same only in the next academic year. But he/she is eligible to take up the arrear courses in that Semester End Examinations.

This Procedure is with effect from 19-08-2019 onwards
